Formation of IPR CELL

Intellectual Property Rights (IPR) play a vital role in fostering innovation and creativity within academic and professional circles. Recognizing the growing importance of intellectual property in today's knowledge-driven economy, Christ College of Science and Management has taken a proactive step by establishing an Intellectual Property Rights (IPR) Cell. This initiative is aimed at encouraging and supporting students, faculty, and researchers to protect their intellectual creations and leverage them effectively.

Formation Process

The formation of the IPR Cell involved the following steps:

1. **Constitution of a Steering Committee:** A steering committee was constituted comprising senior faculty members, legal experts, and representatives from various departments.
2. **Policy Drafting:** An IPR policy for the college was drafted, highlighting the roles, responsibilities, and processes related to intellectual property management.
3. **Appointment of Coordinator:** A dedicated faculty member with expertise in intellectual property law was appointed as the IPR Cell Coordinator.
4. **Infrastructure Development:** A dedicated office space with essential resources such as legal documentation tools and a digital repository for patent tracking was established.

The IPR Cell consists of a diverse ensemble of participants, including the Principal, Vice Principal, Legal advisors, student representatives, and staff coordinators. This inclusive

composition empowers the IPR Cell to efficiently supervise and manage the implementation of intellectual property rights initiatives within the institution.

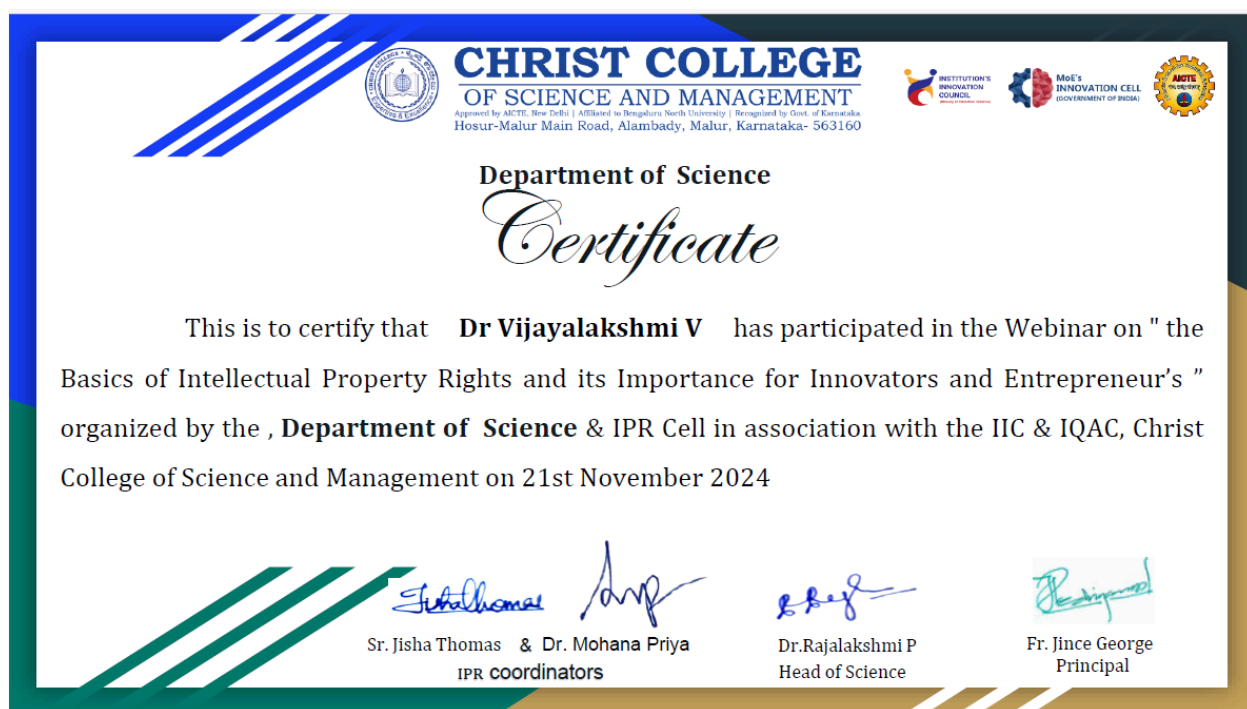

- **November 9th, 2024**

The meeting planned the International Webinar on "Webinar on Basics of Intellectual Property Rights and Its Importance for Innovators and Entrepreneurs" going to be conducted on November 21st, 2024. The meeting commenced with a briefing by Dr. P. Rajalakshmi, the Faculty Coordinator, and Ms. Sarika, the Student Coordinator, outlining the objectives of the
